Introduction

The Women 20 (W20) is an official G20 engagement group established during the Turkish presidency in 2015. The objective is to ensure that the gender considerations are mainstreamed into G20 discussions and translate into the G20 Leaders Declaration as policies and commitments that foster gender equality and women's economic empowerment.

India, under the able leadership of Shri Narendra Modi has made huge strides in ensuring an enabling environment for women. W20 India will strive to take forward the Honourable Prime Minister's vision of India's G-20 presidency to be inclusive, ambitious, decisive, and action-oriented. India will strive to ensure that the G-20 acts as a global "prime mover" to envision new ideas and accelerate collective action over the next one year as laid out by Honourable Prime Minister.

W20 India's vision is to create a world of equality & equity where every woman lives with dignity and the mission is to remove all barriers to women led development and ensure an enabling environment and ecosystem for women to thrive, transcend and transform their lives as well as others.

W20 goals are as follows:

- Bridging the Gender Digital Divide
- Women & Girls as change makers in Climate Change
- Creating Pathways through Education & Skill Development

W20 has a 4C strategy- Collaborate, Cooperate, Communicate and build consensus and Call to Action to achieve its mission and goals. We will include, involve and engage with various stakeholders concerned with women's issues.

Policy advocacy: The emphasis of W20 will be to influence the G20 Leaders' Declaration and G20 Communiqué and take steps to build consensus for active engagement with women entrepreneurs, and commitments to policies that will advance gender equality

W20 has been conducting series of meetings and events in various states to discuss and deliberate on W20 priority issues. Since, the handover of the Presidency from W20 Indonesia, W20 India has held more than 40 events across 10 states in India reaching out to thousands of women and girls. As a universal call to action for all stakeholders, including in business, government, women and civil society, the W20 Agenda articulates priorities for joint efforts, so that all women including women from marginalized sections, can share the benefits of economic growth and development, with no one left behind.

W20 will bring out various knowledge products- white papers, policy briefs, video documentaries, opinion pieces, handbook and communique with the purpose of influencing G20 nations and leaders to make women's agenda at the core of G20 deliberations.

Dr. Sandhya Purecha, Chair W20



Dr. Gulden Turkkan, Founder Chair of W20



This year, in 2022, she has been appointed as the Rual women Co-Chair of the W20 under the presidency of W20 Indonesia. She is now a member of the Presidential Council of KAGIDER. In KAGIDER, she undertook the leadership to promote establishment of W20 and she was appointed as the founding President of the W20, the women outreach group of the G20 that supports gender-inclusive business and economic growth for all G20 countries. he was behind a very successful program known as FEM – an equal opportunity program at the workplace. She works as consultant and mentor for various small to large companies establishing steps for their progress and development. She has been elected to be the President of the Board of International Women's' Forum in Turkey in 2019 and now she is serving her second term as the president.

Shri Amitabh Kant, Sherpa G20



Amitabh Kant is a member of the Indian Administrative Service, IAS. He is presently G20 Sherpa of India during its Presidency year. He was CEO, NITI Aayog (National Institution for Transforming India)- the Govt of India's premier policy Think Tank & prior to that Secretary, Department of Industrial Policy & Promotion. He is the author of "Branding India - An Incredible Story" , Incredible India 2.0 and has edited The Path Ahead "Transformative Ideas for India" and has been a key driver of "Make in India", Startup India, "Incredible India" and "God's Own Country" initiatives which positioned and branded India and Kerala State as leading manufacturing tourism destinations. These campaigns have won several international awards and embraced a host of activities - infrastructure development, product enhancement, private-public partnership and positioning and branding.. He has worked as Secretary, Tourism, Kerala, Joint Secretary, , Govt of India, District Collector, Kozhikode & CEO, Delhi- Mumbai Industrial Corridor.

Dr. Bhagwat Kishanrao Karad, MoS Finance, Government of India



Dr. Bhagwat Kishanrao Karad is Union Minister of State for Finance, Govt. Of India, a Retired Pediatric Surgeon, Member of Parliament, Rajya Sabha, Maharashtra. Dr. Karad is also a Social Worker and has organised several surgical camps for children; free seed distribution to poor farmers belonging to Aurangabad district; provided food, sanitizer and transport to migrant workers during COVID 19 pandemic condition. Dr.Karad has also served as Deputy Mayor and Mayor of Aurangabad. Apart from this he served as a Director of Rural Electrification Corporation, Government of India.

Smt. Smriti Zubin Irani

Hon'ble Minister for Women & Child Development, Government of India



Smt. Smriti Zubin Irani is currently serving as the Union Minister for Women & Child Development and Minister for Minority Affairs. She has previously served as the Union Minister for Education. She is India's youngest Union Cabinet Minister in the Government and the first woman to hold office as Minister for Education and as Minister of Textiles. During her tenure as Education Minister, Mrs. Irani introduced various educational reforms to upscale India's capacities in the field of research, innovation and technology. She was instrumental in conceiving the New Education Policy of India and initiated several large scale projects including India's first MOOC platform SWAYAM, the National Digital Library and a Global Network of Academicians called GIAN. She launched IM-PRINT to foster research, innovation and technology among students and academia. She successfully pursued Permanent Commission for Women in the Indian Army by facilitating legal aid to women officers. She is credited with launching of 'Saksham'- the first ever Vision Document released by any political party in India underlining policies, programs and implementation tools for the upliftment of the Differently-abled in India. Besides being an active social & political activist, Smt. Smriti Irani has had a successful career as a Media Professional for over two decades. During this period, she worked across different fields of media including creating content for news & entertainment Television networks, films and theatre projects in 4 Indian languages. She has also authored a book and contributed as a column writer to 2 national dailies.



Smt. Dharitri Patnaik, Chief Coordinator W20 Secretariat

Dharitri Patnaik has more than twenty seven years of experience working to empower some of the most vulnerable sections of the society, including women, children, and underprivileged people of India. Dharitri has worked on a variety of issues and across various sectors in the areas of international development, poverty alleviation, social reform, women & child development – both from a policy and advocacy perspective as well as developing and managing on the ground operational initiatives. In 2014 she founded Humara Bachpan Trust (an international Award winning organisation) - which works with people living in poverty. In 2017 March she launched an initiative called SAMBHAVI- Women’s empowerment with enterprise and employability. Since its initiation, more than 50,000 women working in informal sector have been trained in life skills. Dharitri is also the Chairperson of Diversified Energy Solutions Pvt Ltd & Jivada Ventures Pvt Ltd. Dharitri has a Masters in Social work from Tata Institute of Social Sciences, Mumbai and a Masters in Public Administration from Harvard University, USA.

SESSION I

Empowering Women in Nano, Micro, & Startup Enterprises

Monday 27th Feb | 11.30 a.m. to 12.30 p.m

Background:

Women represent forty percent of early-stage entrepreneurs active in the world today. They make up one in three high-growth entrepreneurs, and are one-third of entrepreneurs focused on national and international markets. Women in upper-middleincome countries are some of the most innovative, high-growth entrepreneurs in the world, and at parity with men regarding international market focus. As a result of the COVID-19 pandemic, women and men were equally less likely to start a business, but women faced sharper declines in startup rates in 2020. Women in upper-middleincome countries fared somewhat better, however, and their startup intentions and actual startup rates rose by 4% and 11%, respectively, from 2019 to 2021. Some common challenges faced by women entrepreneurs the world over are that fewer sectors are women friendly; women lack role models and social and institutional support to become entrepreneurs; they face poor funding prospects and lack of access to professional networks, sometimes lack of education, and limited industry knowledge; women feel pressure to stick to traditional gender roles, respect social constructs, and balance responsibilities for family and business; they may have limited mobility and are sometimes considered risk-averse or that the competition is great; they also may have concerns for safety.

- Review the state of play regarding women entrepreneurs around the world
- Share best practices to increase the number of women entrepreneurs
 - Discuss policy recommendations to promote women-led entrepreneurship

SESSION II

Role of Women as Changemakers in Climate Resilience Action

Monday 27th Feb | 12.30 p.m to 1.30 p.m.

Background:

Climate change crisis coupled with gender inequality is a challenge and it poses threats to health, safety, livelihood for women and girls around the world. Climate disasters have been shown to increase gender-based violence. Around 21.5 million people are displaced each year globally because of climate-related issues, and children and women are 14 times more likely than men to die or be injured due to a natural disaster.³ The changing weather patterns affect rural women's labour force participation in agriculture and their agricultural production. Women comprise 43% of the agricultural labor force in developing countries. Therefore, women are impacted by any strains on agricultural production in terms of managing household poverty and food scarcity.⁴ During periods of drought and erratic rainfall, women, as primary procurers, work harder to secure food, water, and cooking fuel for their families. This puts added pressure on girls, who often have to drop out of school to help their mothers manage the increased burden.⁵ Around the world, girls are the first to leave school to support their families and take on extra domestic chores created by new climate conditions. Girls are also less likely to re-enroll in school than boys. It has also been observed that women often have a strong body of knowledge and expertise that can be used in climate change mitigation, disaster reduction and adaptation strategies. Furthermore, women's responsibilities in households and communities, as stewards of natural and household resources, positions them well to contribute to livelihood strategies adapted to changing environmental realities. Hence it is high time we talk about impact of climate change and the linkages between women's empowerment & global climate action and encourage women to become Eco Change makers and bring the revolution change which is the need of the hour.



SESSION IV

Improving Access through Infrastructure & Skill to bridge the Gender Digital Divide

Monday 27th Feb | 3.30 p.m to 4.30 p.m.

Background:

While Information Communication Technology (ICT) is recognized as having the potential to promote gender equality and women's empowerment, a digital gender divide—that takes the form of girls and women having less access to and making less meaningful use of ICTs—has been identified which risks exacerbating gender inequalities. The digital divide can be explained as the inequalities between the digital “haves” and “have-nots” in terms of access to and use of the internet and the ICTs. The gender digital divide specifically refers to the global phenomenon of women and girls' access and use of ICTs being less than that of men and boys. For example, women are twenty percent less likely than men to own a smart phone, and those they possess are less likely to support mobile internet use and more likely to have simpler features.³ Women are also rarely the primary owners of a mobile device, and are more likely than men to share or borrow a mobile phone, often within a household or from a male family- member. Women also use digital services less often and less intensively, and they access the internet less frequently, as compared to their male counterparts. In addition, NFHS data indicates that a higher Percentage of urban women own mobile phones than rural women. All these disparities in ICT use risk limiting the ability of girls and women to take advantage of the opportunities offered by digital technologies, and to be full political, social and economic actors in the digital society.

Session Objective:

To identify causes of and effective action to mitigate the Gender Digital Divide, in order to close the gap and foster increased uptake of digital technologies by women and girls at both the urban and grassroots levels.

Creating Pathways for Women through Education & Skilling

Background:

Investing in women's education and skills development is one of the most urgent and effective means to drive progress on gender equality, poverty eradication, and inclusive economic growth.¹ Despite growing evidence of the positive outcomes of women's economic empowerment, women continue to experience unequal access to education and skills development and face barriers to securing decent employment and opportunities to thrive as entrepreneurs. Women's access to resources, including land and loans, may be restricted by discriminatory laws, for which they continue to shoulder an unequal share of unpaid care work.³ Low skills perpetuate poverty and inequality particularly with respect to women. When done right, women skills development can reduce un- and underemployment, increase productivity, and improve standards of living. Helping women develop and update their skills makes economic sense. A university educated young woman is almost two times more likely to complete the labour market transition than a less-educated young woman. Yet, most countries continue to struggle in delivering on the promise of skills development. There are huge gaps in basic literacy and numeracy of skilled women and working-age populations.² The development of skills amongst women can contribute to structural transformation and economic growth by enhancing employability and labor productivity and helping countries to become more competitive. Hence it becomes imperative to educate and skill women so as to increase access of women to decent employment and entrepreneurial opportunities.

Session Objective:

Encouraging and empowering women and girls through skill development and education in order to create pathways for them to take up available income generating opportunities and also create new entrepreneurial setups which in-turn will contribute to structural transformation and economic growth.

SPECIAL SESSION

Breaking the Barriers: Stories of Unconventional Women

Tuesday 28th Feb | 9.30 a.m. to 10.30 a.m.

Background:

In every country around the world women face multiple barriers and gender-based discrimination in the work place. The discrimination sets in early—from the kind of education girls get or till which age, to the kind of work they are channeled into. In both private and public spheres, women face occupational segregation due to cultural mindsets and stereotypes. These obstacles make it harder for women to get on an equal footing with men in the world of work. It is observed in job roles where women have broken the stereotype and taken jobs which were more likely to be done by men, the dropout ratio is more than twice as many women leaving or changing the job-role(33%) after joining as compared to that of men (14%). Only 67 countries have laws against gender discrimination hiring. Even though women manage to enter the workforce in relatively equal numbers as men, the rise to the top can be slower and harder for women. With all these challenges hanging over their heads women are managing to break the glass ceiling. They are fighting this battle every day and emerging as heroes. The number of working women is rising showing that the choice they have of turning their lives for the better is with them. They have a resounding say in the matter of career, profession and lifestyle and are becoming less dependent on the diktats of men. Women are brandishing against all stereotypes by excelling and outshining in fields which were male-dominated till now. Such women are setting raving examples for other women to pave their path and carve their own success stories.

Enablers for Women-led Development: Policy & and Legal Frameworks

Background:

Laws around the world largely fail to protect the rights of women to non discrimination, respect for family life, labor market inclusion, and a life free from violence. Policies focused on gender traditionally, have failed to address the specific needs of women. Women face additional barriers to their socioeconomic participation compared to men resulting in significant employment gaps and high exposure to gender-based violence. They also face various constraints which withhold their development. Such as requiring a spouse's permission to work outside the home, limited public knowledge about women's rights, and uneven implementation and enforcement of gender-neutral laws. There is a lot that has been done but not enough has been achieved to ensure gender equality.

Session Objective:

Share stories and discuss laws that facilitate women led development as well as legal reforms and framework to further advance women's economic empowerment.
